NOTICES OF MOTION

1. NOTICE OF MOTION: UTILIZATION OF WARD FUNDS ALLOCATED FOR YOUTH, WOMEN AND PERSONS WITH DISABILITIES (HON. ANTHONY MNG'AMBWA, MCA, BURA WARD, CHAIRPERSON, COMMITTEE ON YOUTH AND SPORTS)

Article 54, 55 and 56 be corrected.

AWARE THAT, Chapter 3 of the Constitution of Kenya, 2010 recognizes the youth, persons with disabilities and minorities and marginalized groups in all spheres of development including; putting in place affirmative action programmes designed to ensure that minorities and marginalized groups, and providing access to opportunities to associate, be represented and participate in political, social, economic and other spheres of life;

FURTHER AWARE THAT, this County Assembly passed the 2020/2021 Financial Year Budget with provisions for funds meant for empowering the youth, women and persons with disabilities in the wards;

CONCERNED THAT, these funds were appropriated by the area Members of County Assembly and therefore have the right to be involved in identifying viable groups and projects for funding in their respective wards;

NOW THEREFORE this Hsouse resolves that the procurement process for the empowerment programmes for the youth, women and persons with disabilities should be halted until such a time that the respective County Executive Committee Member meets with all the elected Members of County Assembly to get their input in this said programs.

STATEMENTS

1. **STATEMENT: CLARIFICATION ON THE EXPANSION OF THE NDII-GHAZI ROAD (HON. JONES SOLOMON, MCA, NGOLIA WARD, CHAIRPERSON, WATER AND IRRIGATION COMMITTEE)**

MR. SPEAKER, SIR, in line with the provisions of the Taita Taveta County Assembly Standing Order No. 42, a Member of the House can seek a statement requiring availability of information, clarification or appearance on any substantive issue, circumstances, situations and matters appertaining to the attention of County Governments, the National Government, or any Public Entity where such mandates related to the management of service and leadership to the citizens and institutions, as per the Constitution of Kenya, 2010, and our current laws are concerned;

MR. SPEAKER, SIR, Part 2 of the Fourth Schedule of the Constitution of Kenya, 2010 stipulates that County Transport including County roads in a function of the County Government;

MR. SPEAKER, SIR, it has been brought to my attention that the road from the tarmac at Ndiu heading towards Ghazi is being expanded by fixing beacons to almost 40 meters apart, thus encroaching into people's farms which already have title deeds. This has raised alarm among the affected residents as there is no explanation on what is going on.

In view of the above, I rise to seek a statement from the Chairperson of the Committee on Transport, Roads, Public Works, I.C.T & Infrastructure Development to furnish this House with the following;

1. Is the Department of Public Works, Housing & Infrastructure aware of this Exercise?
2. Was Public Participation done to get the views of the residents?
3. Are there plans to compensate the affected people by the exercise?
