1.0 CHAPTER ONE: INTRODUCTION

Mr. Speaker Sir, the exercise of allocation of stalls at Moi Stadium Voi and Wundanyi Stadium has raised eyebrows and concerns with most traders and members of the public complaining of favouritism, unfairness and illegal multi-practices of the whole exercise since its commencement.

Mr. Speaker Sir, it is sad to note that there are some traders whom have owned stalls in various County markets for over 15 years since the period of the defunct County Governments, which raises major concerns of whether the County Government does collect revenue in these stalls since most of the contracts between the traders and the defunct Municipal Councils expired.

Mr. Speaker Sir, it is important to note that, these stalls are revenue raising streams for the County, thus there's need to have sanity and fairness during allocation exercises and ensure capable traders are awarded these stalls spaces to avoid scenarios as witnessed in the Voi Highway market where some traders who were allocated stalls spaces failed to complete the construction works within the completion date of 29th February, 2020.

2.0 CHAPTER TWO: COMMITTEE'S METHODOLOGY/APPROACH

2.1 Committee Proceedings

The Committee held over 5 sittings to review and determine the admissibility of the matter.

2.2 Committee Meeting with CECM

The Committee had a consultative meeting with the CECM for Trade, Tourism, Industry & Cooperative Development and her team on 5th October, 2020 at Zoghori Hotel to shed more light on the matter.

3.0 CHAPTER THREE: COMMITTEE FINDINGS

The CECM for Trade, Tourism, Industry & Cooperative development denied the department being involved in whole process of awarding of the stalls at Moi and Dawson Mwanyumba stadia. The said stalls are under Youths and Sports department and not under Trade and that the department was only tasked to advertise. The department is not in possession of the file concerning these stalls and efforts to get the file have not been fruitful.

The process used in the space allocation was flawed as there were many irregularities, illegal money transactions, favouritism where County staffs and National Government officials awarded themselves stalls.

The traders and interested members of the public were asked to deposit the stalls fees directly to the constructors account instead of depositing the money to the County Revenue Fund (CRF) account.

The plans for the two stadiums was never approved by the County Assembly before the commencement of the construction works and also there was no plan from public works departments to have all the stalls constructed in uniformity.

4:0 COMMITTEE CONCLUSION AND RECOMMENDATIONS

4:1 COMMITTEE CONCLUSION

The Committee made the following conclusion;

The whole process of awarding the stalls at Moi and Dawson Mwanyumba stadia was done illegally and the due legal process was not followed. Stalls were being awarded unfairly whereby County staffs and Government officials awarded themselves the stalls and the County Assembly Committee on Trade, Tourism, Industry & Cooperatives Development was not involved in the whole process.

4:2 COMMITTEE RECOMMENDATION

The Committee recommends that the Second County Assembly resolves as follows;

The whole process should be halted immediately and traders and members of the public who paid for the stalls should be refunded. The County Assembly is willing to allocate enough funds for the construction of the stalls around the above-mentioned stadia in the supplementary budget. This will enable the County collect more monthly rents and increment of business permits and hence boost the revenue collection target increment and thus increase our national equitable share from the National Treasury.
