

Pursuant to Section 35 of the County Governments Act (CGA) and Section 6 of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017, His Excellency the County Governor, Andrew Mwadime, nominated Mr. Peter Mnene for appointment as CECM for Agriculture, Livestock, Fisheries and Irrigation; Ms Gloria Wawuda Monikombo for appointment as CECM for Education, Libraries, VTCs and ICT; Mr. Danson Katuu Mzenge for appointment as CECM for Finance and Economic Planning; Ms. Elizabeth Mkongo for appointment as CECM for Lands, Physical Planning, Housing, Mining and Energy; Ms. Christine Zighe for appointment as CECM for Devolution, Public Service and Administration; Mr. Peter Juma Mwandawiro for appointment as CECM for Public Works, Infrastructure and Transport; Ms. Josephine Marura Mwatibo for appointment as CECM for Trade, Tourism, Cooperatives Development and Industrialization; Mr. Grantone Samboja Mwandawiro for appointment as CECM for Water, Environment, Sanitation, Climate Change and Natural Resources; Mr. Shedrack Mwangangi Mutungi for appointment as CECM for Youth, Sports, Gender, Culture and Social Services and Mr. Gifton H. Mkaya for appointment as CECM for Health Services.

The nomination of the 10 persons was conveyed to the Clerk to the Assembly through a letter **Ref no. SF/GOV/TT/ST.7/VOL. 4/17**, dated 5<sup>th</sup> October, 2022. The nominees' Curricula Vitae and testimonials were also attached.

The Speaker of the County Assembly read the Message from His Excellency the Governor communicating the names of the nominees to the House for the position of CECMS on the Tuesday morning Sitting no 006, dated 11<sup>th</sup> October, 2022. Pursuant to Section 7 (1) of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017, and Standing Order 187(4), the matter was referred to the Committee on Appointments for vetting and reporting to the House within fourteen (14) days.

Consequently, and in compliance with Section 7 (4) of the Act, the Clerk of the County Assembly placed an advertisement in the media on **Wednesday 12<sup>th</sup> October, 2022**, inviting the public to submit memoranda by way of written statements on oath (affidavit) on the suitability or otherwise of the nominee. The advertisement indicated that the submissions were to be received by Friday 21<sup>st</sup> October, 2022, by 4:30 pm. By close of the submission deadline, the Committee



had NOT received any submission on the suitability of the nominees or otherwise for appointment as County Executive Committee Members.

Further, in fulfillment of the provisions of Section 7 (4) of the Act, the Clerk of the County. Assembly, on Wednesday 12<sup>th</sup> October, 2022, notified the public through media, the intention of the Committee on Appointments to conduct the approval hearing of the nominees on Tuesday and Wednesday, 25<sup>th</sup> and 26<sup>th</sup> October, 2022, 09.00a.m.

Section 7(8) of the Act provides that that the approval hearing should focus on a candidate's academic credentials, professional training and experience, personal integrity and background. To fulfill the requirement on personal integrity, the Clerk verified from the Kenya Revenue Authority, the Ethics and Anti-Corruption Commission and the Higher Education Loans Board to ascertain the nominees' good standing with the said government institutions. The nominees were also required to submit clearance from the said institutions, which they did.

The nominees appeared before the Committee on Tuesday and Wednesday 25<sup>th</sup> and 26<sup>th</sup> October, 2022, for approval hearings in accordance with the provisions of the Constitution, the Public Appointments (County Assemblies Approval) Act, 2017 and the County Assembly Standing Orders on their suitability, or otherwise, for appointment to the positions of CECMs.

Pursuant to Section 7-10 of the Public Appointments (County Assemblies Approval) Act, 2017, having considered the nominees' curricula vitae, filled Questionnaires pursuant to the Schedule to the Public Appointments (County Assemblies Approval) Act (No. 5 of 2017) and the oral submissions during the approval hearings, the Committee made several findings and observations.

The Committee observed that the following nominees met the integrity threshold, demonstrated knowledge of topical, administrative and technical issues touching on the portfolios to which they had been nominated and had the requisite abilities, academic qualifications and professional experience to be approved for appointment as County Executive Committee Members in accordance with Section 35 of the County Governments Act (CGA) and Section 6 of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017.

 Ms. Gloria Wawuda Monikombo nominee CECM for Education, Libraries, VTCs and ICT;



- 2. Mr. Danson Katuu Mzenge nominee CECM for Finance and Economic Planning;
- 3. Ms. Elizabeth Mkongo nominee CECM for Lands, Physical Planning, Housing, Mining and Energy
- 4. Mr. Grantone Samboja Mwandawiro nominee CECM for Water, Environment, Sanitation, Climate Change and Natural Resources;
- 5. Mr. Shedrack Mwangangi Mutungi nominee CECM for Youth, Sports, Gender, Culture and Social Services and
- 6. Mr. Gifton H. Mkaya for appointment as CECM for Health Services

The Committee also observed that the following nominees FAILED TO meet the integrity threshold, failed to demonstrate knowledge of topical, administrative and technical issues touching on the portfolios to which they had been nominated or did not have requisite abilities, academic qualifications and professional experience to be approved for appointment as County Executive Committee Members in accordance with Section 35 of the County Governments Act (CGA) and Section 6 of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017:

- 1. County Executive Committee Member (CECM) nominee for Agriculture, Livestock, Fisheries and Irrigation, Mr. Peter Matano Mnene did not demonstrate knowledge on topical, administrative and technical issues touching on the department and lacked the requisite abilities and professional experience to be approved for appointment to the office of CECM. His educational qualifications also are not aligned to the Department that he has been nominated to, as he lacks qualifications related to the field that he was nominated to.
- 2. The Committee observed that Ms. Christine Zighe Mwashighadi's qualifications were not in tandem with her appointment as CECM for Devolution, Public Service and Administration. She was unable to articulate herself well during the approval hearing, and that she lacked the requisite administrative and management skills required for the docket which directly deals extensively with County workers and citizens. The nominee also was unable to prove that she would be able to manage the County staff by being firm in circumstances where industrial action might occur.
- 3. The Committee observed that Mr. Peter Juma Mwandawiro had wide experience in teaching as compared to the technical know-how required for the department of Public



Works, Infrastructure and Transport. His sentiments on the need to have projects that would touch every citizen of this County also were construed to negate the whole spirit of devolution and the nominee also seemed aloof as far as the cooperation and consultation required of a CECM is concerned.

4. Members of the committee also were dissatisfied with the competency with regard to the administrative and management abilities of Ms. Josephine Marura Mwatibo, nominee CECM for Trade, Tourism, Cooperatives Development and Industrialization; that despite her Project Management skills, the Department requires a more competent manager to run as is it a sensitive docket to the County of Taita Taveta. The nominee lacked requisite managerial skills and displayed a lack of touch with the ground and the realities facing the Mwananchi and showed poor problem solving skills in the way she tackled that segment of the hearing.

Having conducted the approval hearings for the nominees pursuant to Section 35 of the County Governments Act (CGA) and Section 6-9 of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017, **the Committee recommends that This House** –

- 1. Approves the nomination of Ms Gloria Wawuda Monikombo for appointment as CECM for Education, Libraries, VTCs and ICT, by H.E the County Governor of Taita Taveta
- 2. Approves the nomination of Mr. Danson Katuu Mzenge for appointment as CECM for Finance and Economic Planning, by H.E the County Governor of Taita Taveta
- 3. Approves the nomination of Ms. Elizabeth Mkongo for appointment as CECM for Lands, Physical Planning, Housing, Mining and Energy, by H.E the County Governor of Taita Taveta
- 4. Approves the nomination of Mr. Grantone Samboja Mwandawiro for appointment as CECM for Water, Environment, Sanitation, Climate Change and Natural Resources, by H.E the County Governor of Taita Taveta
- 5. Approves the nomination of Mr. Shedrack Mwangangi Mutungi for appointment as CECM for Youth, Sports, Gender, Culture and Social Services, by H.E the County Governor of Taita Tayeta

# 2.5 Clearance Requirements

Section 7(8) of the Act provides that that the approval hearing should focus on a candidate's academic credentials, professional training and experience, personal integrity and background. To fulfill the requirement on personal integrity, the Clerk verified from the Kenya Revenue Authority, the Ethics and Anti-Corruption Commission and the Higher Education Loans Board to ascertain the nominees' good standing with the said government institutions. The nominees were also required to submit clearance from the said institutions, which they all did.

# 2.6 Issues for Consideration during the Approval Hearing

In determining the suitability of the nominee for appointment, the Committee was guided by section 7(8) of the Act which places focus on a candidate's academic credentials, professional training and experience, personal integrity and background.

In addition, the Committee is required to take into consideration the following issues in accordance with section 7 of the Public Appointments (County Assemblies Approval) Act, 2017

- (a) the procedure used to arrive at the nominee;
- (b) any constitutional or statutory requirements relating to the office in question; and
- (c) the suitability of the nominee for appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.

# (a) Procedure for Nomination

The procedure for appointment of a CECM is outlined in the County Governments Act. The nomination of CECMs is a constitutional prerogative of the Governor as further provided by the County Governments Act.

# (b) Constitutional and Statutory Requirements

The Constitution in addition gives guidelines on how to appoint persons to public office which include -



# (i) Two-third Gender Rule

Article 27 (8) of the Constitution provides that the State shall take legislative and other measures to implement the principle that not more than two-thirds of the members of elective or appointive bodies shall be of the same gender.' In order to ensure compliance with the Constitution, not more than two thirds of members of CEC should be of the same gender.

The Committee noted that of the ten nominees, four are women, which meets the Constitutional threshold of not more than 2 thirds of one gender in the CECM nominees.

# (ii) Representation of regional and ethnic diversity

Section 35 of the County Governments Act provides that the composition of the County Executive shall reflect the regional and ethnic diversity of the people of Kenya.

Section 35 of the CGA states as follows:

- (1) The governor shall, when nominating members of the executive committee
  - (a) ensure that to the fullest extent possible, the composition of the executive committee reflects the community and cultural diversity of the county;
  - (b) take into account the principles of affirmative action as provided for

in the Constitution.

- (2) The county assembly shall not approve nominations for appointment to the executive committee that do not take into account—
  - (a) not more than two thirds of either gender;
  - (b) representation of the minorities, marginalized groups and communities; and
  - (c) community and cultural diversity within the county.

Noting that the County has 20 wards and only 10 CECMs were nominated, the Committee took cognizance of the fact that all the twenty wards could not be represented in the CECM nominations.

#### (iii) Persons with Disability

Article 232 (1) (i) of the Constitution provides that the values and principles of public service includes affording adequate and equal opportunities for appointment, training and advancement, at all levels of the public service, of—

a) men and women; b) the members of all ethnic groups; and c) persons with disabilities.

Further Article 54(2) mandates the State to ensure the progressive realization of the principle that at least five per cent (5%) of members of the public in appointive bodies are persons with disabilities.

The Committee noted that there is one nominee among the ten who is a PwD, which meets the 5 % threshold for PWDs.



# (iv) Youth

Article 55 mandates the State to take measures, including affirmative action to ensure that the youth have opportunities to associate, be represented and participate in political, social and economic spheres of life.

Among the nominees are two Youth, which also meets the threshold required by the law.

# (v) Leadership and Integrity

The Committee, in determining the suitability of the nominees, was also guided by the provisions on leadership and integrity as outlined under Chapter Six of the Constitution. In particular, Article 73 (2) provides that the guiding principles of leadership and integrity includes

- (a) Selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;
- (b) Objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;
- (c) Selfless service based solely on the public interest, demonstrated by
  - (i) Honesty in the execution of public duties; and
  - (ii) The declaration of any personal interest that may conflict with public duties;
- (d) Accountability to the public for decisions and actions; and
- (e) Discipline and commitment in service to the people.

Of importance, is Article 77(5) that requires a State Officer, whether in public or private life to behave in a manner that avoids conflict between personal interest and public official duties. This Article further prohibits a State Officer who has been removed from office under it from holding any other State Office.

Article 77(1) prohibits a full time State Officer from participating in any other gainful employment.

Article 77(2) prohibits an appointed State officer from holding office in a political party. Article 78 disqualifies persons who are not Kenyan Citizens from appointment as State Officers. Further, a State Officer is barred from holding dual citizenship.

In addition, the Committee considered section 10 of the Leadership and Integrity Act, 2012 in particular which provides that –

A State officer shall, to the best of their ability—

(a) carry out the duties of the office efficiently and honestly;



- (b) carry out the duties in a transparent and accountable manner;
- (c) keep accurate records and documents relating to the functions of the office; and
- (d) report truthfully on all matters of the organization which they represent.

The Committee observed that the nominations of the CECM by the Governor meets the constitutional threshold on gender, persons with disabilities, youth and regional balance.

In compliance with Section 7 (4) of the Act, the Clerk of the County Assembly placed an advertisement in the media on Wednesday 12<sup>th</sup> October, 2022, inviting the public to submit memoranda by way of written statements on oath (affidavit) on the suitability or otherwise of the nominee. The advertisement indicated that the submissions were to be received by Friday 21<sup>st</sup> October, 2022, by 4:30 pm.

In this regards, by close of the submission deadline of Friday 21<sup>st</sup> October, 2022, by 4:30 pm., the Committee **had not received any submission** on the suitability of the nominees or otherwise for appointment as County Executive Committee Members.

#### 2.8 Notification of Nominee to Memoranda raised

Having there been no memorandum received on any of the nominees, the Committee did not require any of the nominees to respond to any matter concerning submission of memoranda.



# 3.0 APPROVAL HEARINGS OF THE NOMINEES

The Committee held a sitting on Monday 24<sup>th</sup> October, 2022, to deliberate on the approval hearings and noted the following:

- i. THAT, none of the nominees had notified the Clerk of the County Assembly of their withdrawal from the approval process as outlined under Section 7 (12) of the Public Appointments (County Assemblies Approval) Act, 2017.
- ii. THAT, Article 179 (3) (b) of the Constitution of Kenya provides that the County Executive Committee Members shall consist of not more than one third on the number of Members of County Assembly if the Assembly has less than 30 members or 10 members if the Assembly has 30 or more members. In this regard, it was noted that in compliance with the provisions of the Constitution of Kenya, Article 179 (3) (b), the Governor had nominated ten CECMs.
- iii. THAT, the Committee would therefore proceed with the approval hearings from Tuesday 25<sup>th</sup> October, 2022 to Wednesday 26<sup>th</sup> October, 2022; and
- iv. THAT, the Committee would examine the nominees against the criteria set out in Section 7 and 8 of the Public Appointments (County Assemblies Approval) Act, 2017.

# 3.1.1 MR. PETER MATANO MNENE -NOMINEE FOR CECM FOR AGRICULTURE, LIVESTOCK, FISHERIES AND IRRIGATION

Mr. Peter Matano Mnene, nominee to the office of the County Executive Committee Member for Agriculture, Livestock, Fisheries and Irrigation appeared before the committee on Tuesday, 25<sup>th</sup> October, 2022 at 10:30 am and was vetted under oath pursuant to Public Appointments (County Assemblies Approvals) Act, 2017) and the Standing Orders of the County Assembly. The Committee noted the following:

# Date and Place of Birth

The nominee is a male Kenyan born on 20<sup>th</sup> July, 1960 in Taita Taveta County, Taveta Sub-County. The Nominee confirmed that he is a Kenyan citizen and did not hold any other citizenship.

#### Academic and Professional Qualifications

The nominee holds a Bachelor's degree in Divinity and a Master's Degree in Congressional Mission and Leadership from Luther Seminary, USA.

# **Employment Record**

The nominee worked at Chai Export in Mombasa between 1984 and 1985, Kenya Airways Mombasa from 1985 to 1987, Taita Taveta County Council from 1988 to 1990, served as pastor in charge at Nairobi Lutheran Church between 1996 and 2001. He also served as an assistant Bishop at the Kenya Evangelical Lutheran Church between 2001 and 2002, district pastor and



HIV/AIDS coordinator in Kilimanjaro District between 2005 and 2009 and an assistant Bishop/KELC National Youth Pastor between 2009 and 2013.

#### Honours and Awards

The nominee submitted that he has not been conferred any honours or awards.

#### Income and Net worth

The nominee estimated his net worth to be Ksh. 13 million with the sources of income being rental income, assets, plots, farming and bee keeping.

While he is a founder and member of Kimundia Vegetable Growers, Rekeke Dairy Group, Reuren Environment CBO, Solidarity CBO and Kiringo Farm Produce Surveillance CBO, the nominee is not a member of any professional Association.

# Potential Conflicts of Interest

The nominee declared that he currently does not have any persons or matter that would present a potential conflict of interest as he assumes the position of County Executive Member for Agriculture, Livestock, Fisheries and Irrigation.

The nominee is involved in charity work through writing proposals for CBOs and groups, linking CBOs to investors, Donors and Partners, offering civic education to the community and free guidance and counselling services to children, youth and families.

#### Integrity

The nominee has neither been in a court of law nor mentioned in any investigatory report of parliament or any commission of inquiry in the last three years. He has also never been dismissed or otherwise removed from office for contravention of the provisions of Article 75 of the Constitution.

# 3.1.2 GENERAL AND SECTOR SPECIFIC QUESTIONS TO MR. PETER MATANO MNENE

In order to assess the nominees overall suitability on the position, the committee examined the nominee on general and specific thematic areas which the nominee responded to as follows:-



# On relevance of his qualifications to the position nominated to

The nominee informed the committee that he has been practicing farming for a long time thus understands the dynamics of the sector well. Further, the work of a county executive committee member is to make policies and manage the department and having attained a master degree in leadership he, submitted that, he is up to the task and technical issues will be handled by technical personnel thus the didn't require him to have the technical know-how in the sector.

# On use of modern technology in agriculture livestock and fisheries

The nominee informed the committee that the county needs to embrace GMO farming since it increases production and minimizes use of pesticides and also tissue culture in bananas and improvement of livestock breeds.

# On entrenching the youth in agriculture

The nominee informed the committee that the youth need to be facilitated to venture into agriculture as this will act as a form of employment. He submitted that he would create more arable land and avail it to the youth since most of them don't own land.

# On policies, laws and regulations regarding agriculture, livestock and fisheries

The nominee informed the committee that he has no knowledge of neither county nor national policies, laws and regulations but will research on them when/if approved to serve in the docket.

#### On key challenges facing the sector

The nominee informed the committee that the key challenge facing the sector is unavailability of livestock markets and the existing ones are not consistent and reliable to farmers plus unfair completion from large scale farmers who have now dominated both local and regional markets in the county.

# On agricultural and veterinary extension services

The nominee submitted to the committee that on what the county needs, he would need to get a clear picture what challenges this key area facing and put proper mechanisms moving forward. He did not mention any challenges in particular.

#### On factors of animal production

The nominee was not able to identify even a single factor of animal production.

#### On bee keeping, poultry farming, fisheries, livestock markets and illegal grazing

The nominee informed the committee that the biggest challenge is livestock markets, that they are not consistent despite animal farmers doing so much but end up being manipulated by



brokers and middlemen. Given the chance, he will encourage them to form cooperatives so as to have more negotiation power in selling their livestock.

People also need to be encouraged to embrace bee keeping since not many people are practicing it.

On poultry farming, people should be encouraged to do poultry farming since its cheaper and also has a ready market in the county.

#### On value addition

The nominee informed the committee that the county needs to partner with donors to set up tomato and banana processing plants so as to process them to products like tomato sauce. This will create employment and increase earnings to farmers.

#### On animal diseases outbreak

The nominee informed the committee that he will involve the experts in the department and also the national government in case of an outbreak to tackle the matter.

The nominee is a female Kenyan born on 24<sup>th</sup> July, 1979 in Taita Taveta County. The Nominee confirmed that she was a Kenyan citizen and did not hold any other citizenship.

# Academic and Professional Qualifications

The nominee holds a Bachelor's degree in Education Arts from Maseno University and a Master of Business Administration from Kenyatta University.

# **Employment Record**

The nominee worked as a BOG teacher at Mwafuga High School in 2004. #### 3.2.2 GENERAL AND SECTOR SPECIFIC QUESTIONS TO THE NOMINEE

The committee posed several questions on his knowledge of Public Service. The nominee responded as follows:

#### On relevance of her qualification to the docket

The nominee informed the Committee that she is a trained teacher, having served in the Education sector for long and that her Master's degree gives her requisite managerial qualifications to handle the docket. Having held a senior position in a Technical College, the nominee submitted that it gave her experience to understand the Education sector widely.

#### On key Achievements

She spear-headed digitalization of functions like teaching aids and schemes of work and coordinated the establishment of virtual classrooms in Coast Institute of Technology during the COVID-19 pandemic

#### On key challenges in the delivery of service by the docket

The nominee informed the committee that the big challenge in the docket is lack of sufficient human resource.

# On aspects of education poised to handle in the docket, their challenges and plans on addressing them

The nominee pointed out to the committee that the aspects included libraries, education county board. She explained that the challenges involving libraries incudes, books not reaching the



pupils and the students which was done using mobile library. The nominee said that to overcome the challenge, she will sit down with the relevant to the docket and sponsors so that they can have a policy to embrace ICT so that the students can access the books online.

The nominee stated that there are a number of VCTs that have been put up recently and they do not have the required equipment and machinery and to address the challenge she stated that she will sit with Finance and Economic Planning Department and ensure that the VTCs are well equipped for youth to train effectively.

# On laws and policies that are operational and non-operational in the County

The nominee explained to the Committee that she is aware ECDE policy which she was not sure whether it is operational or not. She also mentioned the Taita Taveta County Education Fund Bill 2018.

# On post qualification experience to the docket

The nominee explained to the committee that the docket needs someone who is conversant with TVET, TVETA because with the VTCs there must be somebody who is conversant with TVETA guidelines, how the libraries are coordinated and the ECDE.

# On the kind of support that the docket expects from:

#### Devolution and Administration

The nominee explained to the committee that she has to work closely with the department in order to be within the objects of devolution.

#### Finance and economic planning

The nominee explained that for smooth running of her department, then there must be goodwill between the two departments to be able to get adequate financing.

# **ICT** and Industrialization

The nominee explained to the committee that the county needs to digitize some of the functions, embrace ICT in VTCs and that for virtual classrooms to be adopted, there is need to work with the ICT and Industrialization Department.

# On how to expand library services

The nominee stated that there is need to move with technology in order and come up with eresource materials so that the students can access materials online. She also said that she will set aside places in each ward or sub counties for students to access WI-FI and access e-resource materials.

# On her vision and plans to achieve the same



The nominee said that there is need to recheck on the courses which are offered by scanning the environment and getting to know the problems that the county is facing and being able to mount courses in the VTCs for example focusing on mining course in VTCs since the county is endowed with quit a number of minerals. The nominee explained to the committee that for her to achieve this, there should be a policy in the county to back up and guide her in realising the vision.

# On how to ensure continuity of the feeding program to ECDE learners during drought

The nominee stated that she will work with the County Assembly in coming up with policies to back up the feeding programs for the ECDs children and if the policies take time, she will request for support from Members of County Assembly, people of Taita Taveta County and go the acts of mercy way where will have a kitty for people to contribute.

On how she will work together with other education officers and other education stakeholders in order to improve the Taita Taveta County education standards

The nominee explained that she will work with the County Education Board whose function is to manage and coordinate the operations of basic education and tertiary institutions.

The nominee holds a bachelor's degree in Business Management (Finance and Banking option) and a holder of CPA-K from Times Training College.

The nominee worked as an accountant at Bishop Mkala Academy between 2000 and 2011. He has also served as an Accounts Assistant at Pathfinder International Kenya, as an accountant at Mpeki Hauliers Ltd, Financial Controller at Stansha Company Ltd and Principal Finance officer at the County Government of Mombasa.

# Pro-bono /Charity Work

The nominee is involved in charity work through donations to his local church building projects and equipping youth with necessary life skills.



# Integrity

The nominee has neither been in a court of law nor mentioned in any investigatory report of parliament or any commission of inquiry in the last three years. He has also never been dismissed or otherwise for removed from office for contravention of the provisions of Article 75 of the Constitution.

#### 3.3.2 GENERAL AND SECTOR SPECIFIC QUESTIONS TO THE NOMINEE

The Committee posed several questions on his knowledge of Public Service. The nominee responded as follows:

# On the relevance of his qualification to the docket

The nominee informed the Committee that he has gained a lot of experience and management skills relevant to the docket having worked in private firms and NGOs. He has worked in various capacities for about 20 years as a Chief Accountant, Financial Controller and in Mombasa County Government as the head of finance reporting unit.

# On his key Achievements

He spear-headed the financial department in Mombasa as the Chief Officer. He made sure that financial reports were reported on time to the relevant statutory authorities.

# On how to use modern technology in service delivery

He assured the committee that given the opportunity as the CECM for Finance and Economic Planning, Revenue Department will be automated to achieve efficiency in revenue collection. He also said that he will make sure that all IFMIS modules are operationalized in order to produce timely reports.

# On key challenges in the delivery of service in the docket

The nominee informed the Committee that challenges in the docket that he is nominated to for appointment revolve around pending bills which need to be categorized in aging basis for smooth running of the organization. He said that lack of enough or scarce revenue is another challenge. He told the committee that to overcome the challenge on revenue, he will make sure that the department ventures into new revenue streams in order to increase the County's own source revenue. The nominee also said that lack of cooperation with other stakeholders is also another challenge noting that it is important to involve all of the stakeholders and collaborate with them.

#### On areas of interaction between the CECM and the County Assembly

The nominee said that there is need to have a cordial relationship and work together especially in the budget making process and for seamless running of the whole County noting that it is the role of the CECM to present reports to the County Assembly on the required timelines and also there should be good relationship especially on budget making process.



# On the budget making process

The nominee explained to the committee that budget making process is a critical component. He said budget making process is anchored in the PFM Act that there should be a plan and a process which include how budget estimates and expenditure are dispensed within the County Government. He explained that there are several notable documents which include the CIDP which enshrines the visions of the governor, CBROP- a documents that enables the preparation of the budget planning process, CFSP- a document that serves as a roadmap on the preparation of the budget estimates for both revenue and expenditure estimates which are taken to the County Assembly for scrutiny and there after taken for Public Participation and brought back to the County Assembly for ratification and taken to the relevant authorities for accent.

# On how to increase own source revenue

The nominee explained that the main source of increasing own source revenue is to identify new revenue streams that will be enforced. He stated that another way is evaluation role which has not been done for many years in this County. He stated that it is important to do evaluation role and fees like land rates increase the County's revenue. He also said that Taita Taveta being the leading county in terms of endowed in natural resources. He also said that through this Hon. House, the legislation of all County entities which will enable the County to utilize its resources through enactment of a company that has perpetual succession to trade on the natural resource.

# On measures to take unwarranted expenditures

The nominee informed the committee that sticking to the budget is a way of reducing unwarranted expenditures.

#### On how to tame high wage bill

The nominee explained to the Committee that most of the Counties are above the 35% threshold and one of the ways to tame it is doing thorough staff audit. He stated that it is important for the CPSB to work together with the County Treasury to inform one another on matters ceilings. He also said that employment of staff should be on need basis.

# On obsolete County Property

The nominee informed the committee that this is an issue that can be dealt with right laws like Public Procurement and Asset Disposal Act.

# On County Assets

The nominee explained to the committee that when County Assets are received and taken to the right department, they are tagged which is done according to the departments and the sections where the assets are found. He also explained that the assets are supposed to be registered in the assets register which is a tool for management and reporting.



# On county Investment

The nominee explained that this is a process that deals with public funds and that all counties should consider return for investment to put public money into good use. He also said that in all investments there are studies that need to be done for example the feasibility study and all enabling laws regarding the investment.

# Accountability of County Agencies to the County Assembly

The nominee explained to the committee that county agencies are agencies enacted by law through the county assembly. He explained that County entities are supposed to report to the County Treasury and County Assembly on timely basis as stipulated in the circulars of the National Treasury. He explained that if approved his role will be to make sure that accountability, reporting systems of the funds are well guided. He also said that it is role of the CECM to appoint the fund manager for accountability purposes.

# How to handle pressure from a boss who requires to be given money for personal gain

The nominee informed the committee that as a professional he will strictly adhere to the existing laws and budgets so as to give services to the people of Taita Taveta and not for personal gains.

# On how to handle stalemate between the County Executive and the County Assembly

The nominee stated that he does foresee stalemate between the two arms of government because their roles of execution and oversight respectively, are well articulated in the relevant laws. He said that in case it happens will be guided by the laws such as PFM Act and the Constitution.

#### On disagreements between the CECM and his CCO

The nominee said that CECM is the head of the department and their roles are clearly stipulated in the relevant law documents namely the County Governments Act, 2012 and PFM Act and if the disagreement goes beyond the, he will seek internal intervention.

# On amount of pending bills

The nominee stated that currently the pending bills in the County are at about Ksh 1 billion.

#### On considerations to employ in balancing departmental budgetary allocations

The nominee stated that there is always scarcity in matters revenue therefore it's good to adhere to the budgets to eliminate issues of other departments considered to get more money than others.

# 3.4.2 GENERAL AND SECTOR SPECIFIC QUESTIONS TO THE NOMINEE

In order to assess the nominee's overall suitability on the position, the Committee examined the nominee on general and specific thematic areas which the nominee responded to as follows:-

# On relevance of qualifications to the position nominated to

The nominee submitted to the Committee that her bachelor's degree in Business Administration gives her the necessary managerial expertise needed in the policy making and managerial skills needed in the management of the docket.

#### On use of modern technology

On use of modern technology, the nominee informed the committee that there was need to digitize the county lands registry for ease of search and titling of land.

#### On key achievements

The nominee informed the committee that she was able to help the Tanzania – Bondeni society acquire a title deed and saved over 2000 residents from eviction.

# On challenges facing service delivery on land matters in the county

One of the major challenges in the county on land matters is land ownership. Most people in the county don't have land ownership documents i.e. title deeds and lack of land planning and mapping which has scared away many investors



# On laws that govern land matters

The nominee informed the committee that some of the laws that govern land matters are the Community Land Act, 2016 and the Land Act 2012.

# On key priorities

The nominee submitted that, given the chance, she will ensure that most of the residents in the county will have their land titled and that mapping and surveying of land in the county will be done.

# On knowledge of historical land injustices in the county

The nominee informed the committee on awareness of the numerous historical land injustices including the Machungwani land in Taveta, Singila Majengo in Mwatate, Mkamenyi land in Voi, Mwasima Mbuwa and Isanga Iwishi Ranch during her time as civil society organizer.

# On housing development

The nominee informed the committee that the county needs to partner with developments partners such as the UN Habitat to ensure that each county resident is able to own a home. Further, the Former President Uhuru Kenyatta's agenda on housing will also come handy if implemented in the county to ensure affordable housing to all.

#### On unplanned development in county municipalities

The nominee informed the committee that towns and municipalities in the county need to be planned well. This can be achieved through the directorate of physical planning and enacting of a county spatial planning act that will help regulate the mapping of towns and the county at large.

In order to assess the nominees overall suitability on the position, the Committee examined the nominee on general and specific thematic areas which the nominee responded to as follows:-

# On relevance of her qualifications to the position nominated to

The nominee informed the members that she has the necessary capabilities and know-how to execute the mandate of the docket having attained different academic certificates and especially a bachelor's degree in project management which has many aspects of management. She also has



vast experience in public service spanning for over twelve years as an adult education instructor and currently working as a director county adult education office. She is also the secretary to the Kenya union of civil servants, Taita Taveta county branch. She has handled staff in different capacities and given the chance, she can perform in the department.

#### On key achievements in her career

The nominee informed the committee that she has taught youth and adults and helped them get KCSE certificates and those that were ECDE teachers were able to be absorbed permanently by the county government and the youth went to colleges and universities to pursue further education. Further, she helped many employees secure promotions which had stalled for a very long time due to lack of knowledge on proper channels and procedures to follow for one to be promoted.

#### On use of modern technology

On use of modern technology in the department, the nominee informed the committee that she would be committed to train workers on ISO Certification, emphasize on performance contracting and performance appraisals through creation of an online tool for the same and introduction of a biometric registration of all county workers which will help weed out ghost workers.

#### On youth and employment

On how to solve the issue of youth unemployment, the nominee informed the committee that in the Governor's manifesto one of the agenda was to attract investors to the county to invest in the various sectors and that this will create employment opportunities to the youth. Further, she committed to introduce paid internship programs for youth in the various departments of the county government.

**THAT**, in accordance with Article 78 (1) and (2) of the Constitution, the nominee is eligible for appointment to state office since she is a Kenyan citizen born on 17<sup>th</sup> October, 1982, in Taita Taveta County and does not hold dual citizenship.

- 1) **THAT,** the nominee meets the requirements of Chapter Six of the Constitution on leadership and integrity having obtained clearance from the Ethics and Anti Corruption Commission (EACC), the Kenya Revenue Authority (KRA), the Directorate of Criminal Investigations (DCI) and Higher Education Loans Board (HELB).
- 2) THAT, the nominee has not been charged in a court of law in the past three years.



- 3) **THAT,** the nominee has never been dismissed from office under article 75 of the constitution for contravention of the provisions of Articles 75 (1) (conflict of interest), Article 76 (financial probity), Article 77 (restriction on activities) and Article 78 (2) (dual citizenship) of the Constitution.

#### 3.6.2 GENERAL AND SECTOR SPECIFIC QUESTIONS TO PETER JUMA MWANDAWIRO

The committee posed several questions on her knowledge of Public Service. The nominee responded as follows:

# On his experience in Civil Engineering, Electrical installation and quality control, Mechanical works and Transport

The nominee indicated that his experience in Civil Engineering is majorly on the design and estimating and costing which involve building and coming up with the tendering documents. He said that in the contract of the Civil Engineering the Electrical, mechanical and transport are servicing sections where one liaise with what a department requires and relay a special attention to it.

He also stated that quality control is purely on the works being done. From material coming in, standards being applied, the supervision that goes into it and at the end of the day, progressively checking on the material, the workmanship, as required by the documentation to enable him come up with the structure that will perform the intended purpose. The supervising person has to ensure that the tests are done for the purpose of attaining the quality control.

On the laws that will be governing his operations in the docket



The nominee stated that the specific laws that will govern his operations are the Road Act and Traffic Transport Act

# On the state of Transport, Road infrastructure and contracted civil works per sub county

The nominee said that the he has not moved to all roads in the county but for the few he has visited especially in Voi and part of Mwatate, some roads are not good like the Ronge area is pathetic. The nominee added that it could have been very easy to know specific roads that needs services if all roads had been mapped. Besides having people in the ground there should be a routine inspection like the GIA of the road network within the County.

On the kind of road and civil structures that our county requires, the nominee said that ways can be sort to do our roads economically, major problems that can make our roads impassable is drainage work which needs to really be handled perfectly and upgrade using latest technology that we adapt the low volume level road construction where compaction of the materials will be done to the required dry density and finish it with document and have a quality road.

# On the Relevance of his qualification to the position nominated

The nominee indicated that he has a Bachelor of technology, in Civil Engineering and has already undergone complete masters course work in the same. He added that what he has acquired places him in a very knowhow position of what is to be undertaken.

The journey in the administration element, part of the duties as required by this docket is managing supervising the department. He said that he will confidently manage since he has the knowledge of what he is nominated to do, besides the training he has also been carrying out some supervisory duties with those areas related to civil engineering. The knowledge is not new to him.

# On measures to put in place to ensure the County Government gets quality for money in works undertaken

The nominee stated that he will strictly start with proper designs and finish it with good supervision in order to assure us good value of our work.

# On the transport sector being often forgotten and how to fix it

The nominee said that in order to fix it discussions ought to be done and its by cooperating the involved stakeholders, the operators and firms related to the industry may be brought on board and solutions sought.

# On priority areas to consider in terms of works needed within our towns

The nominee said that the priority area within the county to be considered is to make accessible areas to be properly accessible at the moment as opposed to opening some other areas.



# On the role of his docket in assisting other departments

The nominee said that the role my docket in assisting other department is huge, for example health requires construction work, market areas needs to access roads, infrastructure will be required in all parts of the county and in all department, the docket assists in all areas of other departments.

# On the policy proposals he would initiate to streamline operations of his docket

The nominee stated that a policy on development control where we have approval and inspection should be done. He added that all resourceful persons need to be at least in each sub county. On the transport bill, for them to be properly utilized some pulling shot needs to be done in order to control development and transport, structures to the required standards and right approval with inspection.

# On the modalities of maintenance of county machinery and vehicles from within his docket

The nominee said that they have qualified man power in the maintenance side and these people are paid salary every month, they are competent enough, this will go a long way in reducing expenditure instead of outsourcing. He added that for a proper maintenance then getting the various parts ought to be addressed immediately.

# His views on the fuel levy fund as related to his docket

The nominee said that the fuel levy fund is being given for the purpose of maintenance, rehabilitating and repairing. For him to maximize, the nominee said that the will have to have planned activities for this to show how money is spent, and this will happen by first expressing the need through what they want to do in terms of the work plan. The nominee added that in the distribution of roads then the County Assembly Members needs to discuss and make a proper deal with specific of completion of one road before dealing with another one.

#### On how he will handle Political pressure on incomplete works approved for payment

The nominee indicated that even though the one who appointed him is a politician his conscience may not allow him to approve incomplete works for payment since he is called to give advice and that is a wrong advice to give. He added that if the préssure is too much it will be better if he withdraws or disqualify himself.

#### On lack of maintenance despite several budgetary allocations

The nominee indicated that In line with the integrity element, If they had budgeted for repair or maintenance work to be done then reasons have to be given, it brings down to accountability area. He said that if probably the problem is with the persons, then the management of that needs to up its game, if there is incompetency again they need to improve by being given an extra knowhow to equip them further in order to effectively handle the matter.



#### On lack of periodical maintenance

The nominee said that this may be easy by involving stakeholders by targeting the user around the place with a view of creating employment to our youths. He added that if it is properly done with any amount available, the maintenance need to be planned and periodically carried out, by engaging youths and creating employment and maintain our roads

- 3) THAT, the nominee has not been charged in a court of law in the past three years.

#### 3.7.2 GENERAL AND SECTOR SPECIFIC OUESTIONS TO THE NOMINEE

The Committee posed several questions on the nominee's knowledge of Public Service. The nominee responded as follows:

#### On how to use her managerial profession in the management of the docket

The nominee explained to the committee that having an experience of 12 years, she will use program management development cycle which involves mapping, situational analysis, planning, execution, monitoring and evaluation and will involve different stakeholders in order to see the benefit of the process.

#### On what will accelerate the intra and inter county trade developments

The nominee stated that the most important thing is team work of all government agencies and also involving the voice of community members.

# On the existing lawful platform to be used to cushion county market traders from unfair competition

The nominee explained to the committee that it's necessary to make sure that the weights and measures services are used properly to curb unfair trading practises. She also explained that the county investments development corporations Act which will help in shielding our people from investors who are involved in short-changing them.

#### On relevance of her educational qualifications



The nominee explained to the committee that her degree in international relations has equipped her on matters international, trade and basically being able to engage, partner with the diverse countries and communities.

#### On challenges facing SMEs

The nominee explained to the committee that lack of capital to start and fund their businesses, unfair trade practises, expensive trading fees and already existing detrimental trading practises are some of the challenges facing SMEs.

# On unexploited tourism potentials and their remedies

The nominee explained to the committee that poor infrastructure, poor or no advertising and marketing of our tourism cites, and low local tourism are some of the causes to underexploited tourism in the county. She stated that some of the solutions include improving marketing and branding of the tourism cites through e-marketing hub, initiating incentives to promote local tourism and promote awareness on homestay concept which benefits the locals form tourism revenue.

#### On inhibitors to the growth and development of cooperatives

The nominee explained to the committee that lack of awareness by the community members on how the cooperatives function is the main inhibitor to cooperatives.

# On the role of County Government in cooperative development

The nominee explained to the committee that it is important for the County Government to support cooperatives by facilitating them to have member education days in order to share information and ensure that the cooperatives developments societies are being transparent in sharing their audits.

#### On challenges faced by the Taita Taveta County in industrialization

The nominee explained to the committee that lack of capital and lack of opportunities by the young people to work in the industries due to lack of knowledge. She also explained that another challenge facing Taita Taveta in industrialization is the investors bowing out due to processes taking too long or too many complications.

# On measures that the department will take to increase, collection of local revenue through trading licences

The nominee explained to the Committee that automation of payment of services is established to curb corruption. She also said that promotion of tourism to the locals will increase the local revenue. Also, making use of the youth who take good images from their professional cameras, copyright them and sale them on international platforms which will generate income for the county. She stated that putting up play and lactation for women in the market.



#### On the vision of the department in three years

The nominee stated that she is looking forward to an empowered community with improved standards of living and quality life.

#### On regional economic blocs

The nominee explained to the committee that if the county strategically position itself will be able to market our products internationally, attract investors and build industries in the county.

#### On Intergovernmental relations in devolution

The nominee explained to the committee that it is important to consult the national government on matters on policies involving intergovernmental and inter-county trade relations.

### On areas of technology in the docket

The nominee explained to the committee that she will work with the ICT department to come up with digital villages and be able to increase digital literacy.

#### 3.7.3 COMMITTEE OBSERVATIONS ON THE SUITABILITY OF THE NOMINEE

The Committee, having considered the nominee's filled questionnaire pursuant to the First Schedule of the public appointments (County Assemblies Approval) Act No. 5 of 2017, her curriculum vitae and having heard her oral submission during the approval hearing, made the following observations on her suitability for appointment as county executive committee member for Trade, Tourism, Cooperative Development and Industrialization:-

**THAT**, in accordance with Article 78 (1) and (2) of the Constitution, the nominee is eligible for appointment to state office since she is a Kenyan citizen born on 29<sup>th</sup> March, 1987 in Nairobi County and does not hold dual citizenship.

- 1) **THAT**, the nominee meets the requirements of Chapter Six of the Constitution on leadership and integrity having obtained clearance from the Ethics and Anti Corruption Commission (EACC), the Kenya Revenue Authority (KRA), the Directorate of Criminal Investigations (DCI) and Higher Education Loans Board (HELB).

- e) The nominee also sponsored a goat eating party for Kiboko house -Kenyatta high school in 2017 after performing well in all disciplines e.g, academics, sports etc at a cost of Ksh. 50,000
- f) The nominee paid deposits for obstetric emergencies at St. Joseph Shelter of Hope Ikanga, during the National Health worker's industrial unrest. (5 women, Ksh. 30,000 each)
- g) The nominee used his car several times to respond to transport needs of his neighbours during medical emergencies in his village.

#### Integrity

The nominee has neither been charged in a court of law nor mentioned in any investigatory report in the last three years. He has also never been dismissed or otherwise for removed from office for contravention of the provisions of Article 75 of the Constitution.

#### 3.10.2 GENERAL AND SECTOR SPECIFIC QUESTIONS TO THE NOMINEE

In order to assess the nominee's overall suitability on the position, the Committee examined the nominee on general and specific thematic areas which the nominee responded to as follows:-

#### On whether or not Health should have been devolved

The nominee submitted to the Committee that devolution of Health Services was both a good and bad thing; good because since independence, health services were far from the Mwananchi for being run by the National Government in Nairobi, thus devolution brought the services closer to the people. On the other hand, the nominee expressed his concerns that the Country seemed not ready for devolution of Health Services due to the amount of disorganization in the Health Sectors in the counties, as well as lack of resources because devolving a function must be followed by resources. He submitted that Primary Healthcare should have been devolved while level 5 and 6 levels should have remained with the National Government.

#### On the shortcomings of the Health System in Taita Taveta County

The nominee submitted to the Committee that the shortcomings of the Health can be summarized using the 7 pillars of health care which are inclusive of:

- a) Healthcare Products and technologies which have been inadequate
- b) Human Resources for Health- where the County has a shortage of health workers and lack of requisite skills.



- c) Health Infrastructure which includes equipment and buildings in which case the County lacks facilities such as ICUs.
- d) Service Delivery- he noted that the Health Department has systemic failures
- e) Healthcare financing- which he noted was the biggest challenge in supporting the other pillars
- f) Health Information Systems including records, data, etc which are key in planning. The challenge with Taita Taveta, he stated, is that the County is still using analogue/manual systems which are cumbersome, there's a lack of internet and therefore key data and commodities are lost.
- g) Research in Health- He indicated that there's little research in health which affects service delivery and that partners are needed to assist in Research to inform some decisions in the sector.

#### On why the budgetary allocation for Health Department needs to be increased

The nominee submitted to the Committee that the Budgetary Allocation for Health is supposed to be between 12 and 15 % of the County Budget according to the Abuja Declaration of the 1990s but that currently that does not happen. This Financial Year, the County's Budget is at 9% of the whole Budget; it is small and he would negotiate for increase of the budgets in the Executive and the Assembly to be able to care for healthcare financing, without which health services will be compromised.

#### On the need to focus on Preventive and promotive and not curative medicine

The nominee agreed that the County is focused more on curative healthcare because most people are already sick. He however submitted that preventive healthcare is cheaper in terms of resources, both finances and human resources, and that the County needs to emphasize on preventive and promotive healthcare. This should be done by empowering public health officers to create wide awareness on good diet and healthy life styles to reduce the disease burden.

#### On the Facility Improvement Fund

The nominee noted that Facility Improvement Fund is a great idea to improve healthcare in Taita Taveta County in that the monies should not be used at source as it opens a door for corruption. He said that with proper structures and policies, implementation of FIF will greatly improve the equipping of healthcare in the County.

#### On Moi county referral Hospital being a level 5 hospital

The nominee submitted that a level 5 referral hospital has all specialized services, requisite equipment, specialists in terms of Human Resources, all Consultants, timely and constant commodity supply etc and that what makes Moi County referral hospital not qualify to be one is the lack of funds to provide all the above mentioned facilities and resources.



# On handling GBV as a major Public Health Concern

The nominee submitted that Gender Based Violence is actually a real issue in healthcare and that it can be resolved through collaboration with the communities to stop retrogressive cultural practices that cause GBV, Ensuring that GBV centres in hospitals are strengthened and services offered there such as provision of free P3 forms, Post- Exposure Prophylaxis, and counseling of GBV Victims streamlined, and coordinating with other stakeholders such as security agencies to reduce GBV.

#### On how he would handle issues of mental health

The nominee submitted that mental health issues are existent and on the increase due to many factors and thus there is still a lot of stigma on mental health. He promised that if appointed to the CECM position, he would ensure operationalization of the Wesu Rehabilitation Centre which was built by NACADA in collaboration with the County Government, to offer rehabilitation services to those with mental issues arising from drug abuse. He also submitted that there is a lack of personnel in hospitals including psychiatrists as most facilities only have psychiatric nurses and clinical officers. He submitted that he would ensure enough human resources are put in place as well as putting in place health education to change perspectives on mental health and equally concentrate on preventive measures for factors causing mental illnesses.

#### On how he would handle cases of corruption in the Health Sector

The nominee submitted that corruption in the health sector has been there since before including theft of technologies and products, finances, compromised procurement processes that lead to theft and in form of conflict of interest. He told the Committee that he would ensure streamlining of tender Committees and the tendering processes, as well as instituting disciplinary and lawful actions against corrupt officers.

#### On provision of free treatment of the elderly in the County

The nominee submitted that the elderly are susceptible to a lot of health challenges due to their age and their poor economic status and that, being that the free treatment of is provided for in the County Health Act, he would ensure that resources are found to ensure that the elderly and other special groups continue to enjoy free treatment.

#### On how he will handle health staff who are running parallel businesses

The nominee submitted that he is not aware of such businesses as all the medics are paid a non-practicing allowance by the County but promised that if appointed to the office of CECM, he would initiate investigations and take appropriate action against anyone found culpable as it presents a case of conflict of interest.

#### On how he will resolve the issue of lack of Essential Medicines and medical Supplies

The nominee submitted that lack of essential medicines and supplies is largely caused by poor policies and systems, noting that KEMSA should be the first shop for medical supplies for

government health centres and hospitals, as supplies from other sources can compromise on safety and quality of supplies. He further elaborated that KEMSA has good distribution channels and that a central drug store in the County makes the County incur an extra expense of delivery of supplies which could otherwise be delivered for free by KEMSA. He also submitted that KEMSA is cheaper and offers good quality supplies; it is flexible in offering credit services for supplies and that he would make sure that the County opens and account with KEMSA and that each facility makes its orders directly to KEMSA as per need to avoid wastage and supply of items not needed.

# On the issue of referrals and poor ambulance services

On the issue of referrals, the nominee submitted that he will work on streamlining referral processes and that the available ambulances- which he said are 7 as at present- are zoned to be able to offer better services. He noted that it is not practical to have an ambulance for every health institution in the County because of operation costs.

# On how he will handle persistent strikes and industrial action by medics

The nominee submitted to the Committee that industrial action by medics is caused by delayed promotions, lack of proper re-designation upon requisite qualifications and poor working conditions such as lack of equipment and personal protective gear. He promised to ensure better working of the County Health Management Committee which would submit recommendations to the HR Committee for further submission to the County Public Service Board for appropriate action. The nominee stated that he will ensure that constant engagement with health workers is maintained and dialogue promoted.

#### On whether UHC is achievable

The nominee submitted that Universal Health Coverage Access is a right in the law and that it must be delivered even if it means seeking funds from other partners, before turning to NHIF and other plans for health. He enumerated that UHC includes making services available, apart from just removing the cost barrier to quality healthcare.

#### On Community Health Workers/ Volunteers

The nominee submitted that CHWs/CHVs are key to the Community Health Strategy and that they should be supported through constant training, giving of recognition certificates and stipends to motivate and facilitate their work. He promised to work with partners to give stipends to the CHWs as it would cost approximately Ksh 32 million to give each CHW Ksh 2000 stipend per month.



#### 3.10.3 COMMITTEE OBSERVATIONS ON THE SUITABILITY OF THE NOMINEE

The Committee, having considered the nominees filled questionnaire, pursuant to the First Schedule of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017, his curriculum vitae and having heard his oral submission during the approval hearing, made the following observations on his suitability for appointment as county executive committee member for Health Services;

- 1) **THAT**, in accordance with Article 78 (1) and (2) of the Constitution, the nominee is eligible for appointment to state office since he is a Kenyan citizen born on 18<sup>th</sup> January, 1979 in Taveta, Taita Taveta County and does not hold dual citizenship:
- 2) **THAT**, the nominee meets the requirements of Chapter Six of the Constitution on leadership and integrity having obtained clearance from the Ethics and Anti Corruption Commission (EACC), the Kenya Revenue Authority (KRA), the Directorate of Criminal Investigations (DCI) and Higher Education Loans Board (HELB).
- 3) THAT, the nominee has not been charged in a court of law in the past three years.
- 4) **THAT**, the nominee has never been dismissed from office under article 75 of the constitution for contravention of the provisions of Articles 75 (1) (*conflict of interest*), Article 76 (*financial probity*), Article 77 (*restriction on activities*) and Article 78 (2) (*dual citizenship*) of the Constitution.
- 5) **THAT**, the nominee demonstrated knowledge of topical, administrative and technical issues touching on the department of Health Services has the requisite abilities, qualifications and experience to serve as County Executive Committee Member for Health Services.

#### COMMITTEE OBSERVATIONS

The Committee observed that the following nominees met the integrity threshold, demonstrated knowledge of topical, administrative and technical issues touching on the portfolios to which they had been nominated and had the requisite abilities, academic qualifications and professional experience to be approved for appointment as County Executive Committee Members in accordance with Section 35 of the County Governments Act (CGA) and Section 6 of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017.

- **1. Ms. Gloria Wawuda Monikombo** nominee CECM for Education, Libraries, VTCs and ICT;
- 2. Mr. Danson Katuu Mzenge nominee CECM for Finance and Economic Planning;
- **3. Ms. Elizabeth Mkongo** nominee CECM for Lands, Physical Planning, Housing, Mining and Energy
- **4. Mr. Grantone Samboja Mwandawiro** nominee CECM for Water, Environment, Sanitation, Climate Change and Natural Resources;
- 5. Mr. Shedrack Mwangangi Mutungi nominee CECM for Youth, Sports, Gender, Culture and Social Services and
- 6. Mr. Gifton H. Mkaya for appointment as CECM for Health Services

The Committee also observed that the following nominees FAILED TO meet the integrity threshold, failed to demonstrate knowledge of topical, administrative and technical issues touching on the portfolios to which they had been nominated or did not have requisite abilities, academic qualifications and professional experience to be approved for appointment as County Executive Committee Members in accordance with Section 35 of the County Governments Act (CGA) and Section 6 of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017:



- 1.County Executive Committee Member (CECM) nominee for Agriculture, Livestock, Fisheries and Irrigation, Mr. Peter Matano Mnene did not demonstrate knowledge on topical, administrative and technical issues touching on the department and lacked the requisite abilities and professional experience to be approved for appointment to the office of CECM. His educational qualifications also are not aligned to the Department that he has been nominated to, as he lacks qualifications related to the field that he was nominated to.
- 2.The Committee observed that Ms. Christine Zighe Mwashighadi's qualifications were not in tandem with her appointment as CECM for Devolution, Public Service and Administration. She was unable to articulate herself well during the approval hearing, and that she lacked the requisite administrative and management skills required for the docket which directly deals extensively with County workers and citizens. The nominee also was unable to prove that she would be able to manage the County staff by being firm in circumstances where industrial action might occur.
- 3. The Committee observed that Mr. Peter Juma Mwandawiro had wide experience in teaching as compared to the technical know-how required for the department of Public Works, Infrastructure and Transport. His sentiments on the need to have projects that would touch every citizen of this County also were construed to negate the whole spirit of devolution and the nominee also seemed aloof as far as the cooperation and consultation required of a CECM is concerned.
- 4. The committee was dissatisfied with the competency with regard to the administrative and management abilities of Ms. Josephine Marura Mwatibo, nominee CECM for Trade, Tourism, Cooperatives Development and Industrialization; that despite her Project Management skills, the Department requires a more competent manager to run as is it a sensitive docket to the County of Taita Taveta. The nominee lacked requisite managerial skills and displayed a lack of touch with the ground and the realities facing the Mwananchi and showed poor problem solving skills in the way she tackled that segment of the hearing.

#### **COMMITTEE RECOMMENDATIONS**

Having conducted the approval hearings for the nominees pursuant to Section 35 of the County Governments Act (CGA) and Section 6-9 of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017, the Committee recommends that This House –

- 1. Approves the nomination of Ms Gloria Wawuda Monikombo for appointment as CECM for Education, Libraries, VTCs and ICT, by H.E the County Governor of Taita Taveta
- 2. Approves the nomination of Mr. Danson Katuu Mzenge for appointment as CECM for Finance and Economic Planning, by H.E the County Governor of Taita Taveta
- 3. Approves the nomination of Ms. Elizabeth Mkongo for appointment as CECM for Lands, Physical Planning, Housing, Mining and Energy, by H.E the County Governor of Taita Taveta
- 4. Approves the nomination of Mr. Grantone Samboja Mwandawiro for appointment as CECM for Water, Environment, Sanitation, Climate Change and Natural Resources, by H.E the County Governor of Taita Taveta
- 5. Approves the nomination of Mr. Shedrack Mwangangi Mutungi for appointment as CECM for Youth, Sports, Gender, Culture and Social Services, by H.E the County Governor of Taita Taveta
- 6. Approves the nomination of Mr. Gifton H. Mkaya for appointment as CECM for Health Services, by H.E the County Governor of Taita Taveta

Further, Pursuant to Section 35 of the County Governments Act (CGA) and Section 6-9 of the Public Appointments (County Assemblies) Approval Act no. 5 of 2017, the Committee recommends that This House REJECTS the nomination of the following for the appointment as CECMs by H.E the County Governor of Taita Taveta:

- 3. Mr. Peter Juma Mwandawiro for appointment as CECM for Public Works, Infrastructure and Transport, by H.E the County Governor of Taita Taveta



4. Ms. Josephine Marura Mwatibo for appointment as CECM for Trade, Tourism, Cooperatives Development and Industrialization, by H.E the County Governor of Taita Taveta.
