#### **STATEMENT**

- 1. STATEMENT: STATEMENT REGARDING BOUNDARY DISPUTE BETWEEN KURANZE AND ZIWA AREA IN KASIGAU WARD (Hon. Amos Makalo, MCA, Kasigau Ward, Deputy Minority Leader)
- MR. SPEAKER, SIR, in line with the parliamentary best practices, precedents and conventions, and pursuant to the provisions of the Taita Taveta County Assembly Standing Order No. 42(2) (c) relating to the Sitting's ORDER NO. 7 (STATEMENTS), a Member of the House can seek a statement requiring availability of information, clarification or appearance on any substantive issue, circumstances, situations and matters appertaining to the attention of County Governments, the National Government, or any Public Entity where such mandates related to the management of service and leadership to the citizens and institutions, as per the Constitution of Kenya, 2010, and our current laws are concerned;
- MR. SPEAKER, SIR, there has been boundary dispute between Kuranze and Ziwa area in Kasigau Ward, where the County borders with Kwale County that has been ongoing for a while now. The said area is rich in minerals and Kwale County Government appears to have meddled with the boundary as they have already engaged the area in its land use plan.
- **MR. SPEAKER, SIR,** I would like the Chairperson of Committee on Lands, Human-Wildlife Conflict to furnish this House with the following information:

- 1. What has the department done since receiving information of the ongoing land use plan in Triangle ranch?
- 2. Does the department have the original maps that clearly show the boundary/beacons where Taita Taveta and Kwale Counties are separated? If yes, copies of the same should be submitted.
- 3. Has the department gathered historical evidence that shows Triangle Ranch had consents from both Taita Taveta and Kwale Counties?
- 4. What plans has the department put in place to safeguard our County Boundaries?
