STATEMENT

1. STATEMENT: SUSTAINABLE METHODS OF MAINTAINING COUNTY ROADS (Hon. Isaac Matolo, MCA, Mata Ward, Chairperson, Tourism Committee)

MR. SPEAKER, SIR, in line with the parliamentary best practices, precedents and conventions, and pursuant to the provisions of the Taita Taveta County Assembly Standing Order No. 42(2) (c) relating to the Sitting's ORDER NO. 7 (STATEMENTS), a Member of the House can seek a statement requiring availability of information, clarification or appearance on any substantive issue, circumstances, situations and matters appertaining to the attention of County Governments, the National Government, or any Public Entity where such mandates related to the management of service and leadership to the citizens and institutions, as per the Constitution of Kenya, 2010, and our current laws are concerned;

MR. SPEAKER, SIR, the County Government has over the years been carrying out road maintenance works by murraming, grading and levelling County roads. However, despite the efforts by the County Government to maintain good road infrastructure network, the roads are usually carried away during rainy seasons.

MR. SPEAKER, SIR, I would like the Chairperson of Committee on Transport, Roads, Public Works and Infrastructure Development to furnish this House with the following information:

- i. Are there alternative ways/methods of maintaining County roads to ensure their durability even during rainy seasons?
- ii. What is the cost difference between what we are accustomed to and other models which could serve us for longer periods?
- iii. Are there enhancements which can be done on our murram roads to make them last longer than is currently the case?

iv. Does the Department ensure quality of works is done before issuing out certificates of completion and payments to the contractors?
