The nominee is required to collect a vetting questionnaire from the Office of the Clerk of the County Assembly between 8:00 a.m. and 5:00 p.m., from **Wednesday 17th July, 2024** and should return the questionnaire together with the copies of the documents listed below on or before **Monday, 22nd July, 2024 at 5:00 p.m.:**

- 1) National Identification Card (ID)
- 2) Copies of relevant academic and professional certificates
- 3) Current clearance certificates from the following bodies-**Kenya Revenue Authority (KRA), Directorate of Criminal Investigations (DCI), the Higher Education Loans Board (HELB), a Credit Reference Bureau (CRB) and the Ethics and Anti- Corruption Commission (EACC).**

The candidate is also advised to carry the **ORIGINALS** of the above-mentioned documents on the day of the approval hearing.

Members of the public are invited to attend the Committee Sitting for approval hearing and/or submit any information or comments on the suitability or otherwise of the nominee. Written submissions and evidence of the same may be made by way of sworn-in affidavit or Statement under Oath and sent or hand delivered to the **Clerk, County Assembly of Taita Taveta, P.O.
