1. STATEMENT: <u>CURRENT STATUS AND IMPLEMENTATION OF THE TAITA TAVETA COUNTY VOCATIONAL TRAINING CENTRES ACT, 2024</u> (Hon. Amos Makalo, MCA, Kasighau Ward, Chairperson, Public Accounts and Investment Committee)

Mr. Speaker, Sir, In accordance with parliamentary best practices, precedents, and conventions, and pursuant to the provisions of the Taita Taveta County Assembly Standing Order No. 61 relating to the Sitting's ORDER NO. 7 (QUESTIONS & STATEMENTS), a Member of this House is empowered to seek a statement requiring the provision of information, clarification, or appearance on any substantive issue, circumstance, or matter pertaining to the mandates of County Governments, the National Government, or any public entity. These mandates relate to the management of services and leadership to citizens and institutions, as enshrined in the Constitution of Kenya, 2010, and other applicable laws.

In this regard, I rise to seek a comprehensive statement on the current status and implementation of the Taita Taveta County Vocational Training Centres Act, 2024, a critical legislative framework aimed at transforming the vocational training landscape in our county.

**Mr. Speaker, Sir,** Vocational Training Centres (VTCs) are pivotal institutions for equipping our youth with practical, market-driven skills, providing viable pathways to employment, entrepreneurship and economic empowerment. These centres are essential for addressing the high levels of youth unemployment and underemployment in Taita Taveta County, fostering self-reliance and aligning with the National Government's Bottom-Up Economic Transformation Agenda and Vision 2030.

- **Mr. Speaker, Sir,** the Taita Taveta County Vocational Training Centres Act, 2024, represents a landmark commitment to enhancing the quality, accessibility, and relevance of vocational training, making it imperative that this House is fully apprised of its legislative progress and practical implementation.
- **Mr. Speaker, Sir,** the aforementioned Bill, sponsored by Hon. Daniel Kimuyu, MCA, was duly committed to the Committee on ECDE, Vocational Training Centres, and Libraries for thorough review and consideration. The legislative process progressed smoothly, with the First Reading conducted on 23rd April 2024, marking the introduction of the Bill to this Honourable House. Subsequently, the Second and Third Readings were successfully completed on 17th December 2024, during which this Honourable House passed the Bill, signifying its approval and readiness for assent.
- **Mr. Speaker Sir**, in view of the foregoing and given the critical role of this legislation in empowering our youth and driving socio-economic development, I would like the Chairperson of the Early Childhood Development Education, Vocational Training and Libraries Committee to furnish this House with the following information;
  - 1. Has the Governor assented to the Taita Taveta County Vocational Training Centres Act, 2024, in accordance with the County Governments Act, 2012 and the Constitution of Kenya, 2010?
    - i. If assent has been granted, has the published Act been formally submitted to the County Assembly as required?
    - ii. If the Act has not been assented to, what are the reasons for the delay, and what measures have been put in place to expedite the process, noting that no memorandum has been submitted in opposition to the Act?
  - 2. If assented, has the Act been published in the Kenya Gazette to become law? If not, what steps are being taken to ensure prompt publication?
