Mr. Speaker, Sir, aware that in the month of June, 2025, this Honorable House adopted the report of the Select Committee on Budget, Finance & Appropriations on the Taita Taveta County Program Based Budget for the FY 2025-2026. One of the key recommendations was for allocation for SHI/SHA recruitment under universal health coverage whereby the department of Health Services was allocated Ksh. 90,000,000 for the recruitment of vulnerable members into the Social Health Insurance (SHI)/ Social Health Authority (SHA) scheme under the Universal Health Coverage Program. This allocation aimed at enhancing health coverage and access by vulnerable people in the County.

Mr. Speaker, Sir, in view of the foregoing, I rise to seek a Statement regarding the raising cases of alleged negligence leading to medical errors in orthopedic procedures at the Taveta Sub County Hospital Orthopedic Department.

Mr. Speaker, Sir, the Health and Sanitation Committee was apprised of these allegations during its visit at the facility on 30th April, 2025, in which I was in attendance. The Committee was also informed that the orthopaedic Department is understaffed as it was currently operating with only 2 staff being an orthopaedic plaster technician and a clinical officer who work without a supervisor since the retirement of the previous 2 supervisors and other issues that may be among the causes of the alleged raising cases.

Mr. Speaker, Sir, during the visit, the Committee on Health and Sanitation resolved that the Department of Health Services should post a qualified Orthopedic Technologist to the facility within fourteen (14) days. This resolution was communicated vide a letter dated 2nd May, 2025, referenced TTCA/CS/7/VOL.8(023). However, despite this directive, cases of alleged negligence continue to be reported at the facility;

2. Is the Department aware of the reported cases of alleged negligence?
