STATEMENT

- 1. STATEMENT: STATUS OF BUDGET IMPLEMENTATION FOR DEVELOPMENT PROJECTS FY 2025/2026 IN TAITA TAVETA COUNTY (Hon. Amos Makalo, MCA, Kasigau Ward)
- Mr. Speaker, Sir, in line with the parliamentary best practices, precedents and conventions, and pursuant to the provisions of the Taita Taveta County Assembly Standing Order No. 61(1) relating to the Sitting's ORDER NO. 7 (STATEMENTS), a Member of the House can seek a statement requiring availability of information, clarification or appearance on any substantive issue, circumstances, situations and matters appertaining to the attention of County Governments, the National Government, or any Public Entity where such mandates related to the management of service and leadership to the citizens and institutions, as per the Constitution of Kenya, 2010, and our current laws are concerned; In view of the foregoing, I rise to seek a statement regarding the status of budget implementation for development projects in Taita Taveta County for the Financial Year 2025/2026.
- **Mr. Speaker, Sir,** the County Assembly on 1st October, 2025 during Morning Sitting No.082 approved the current financial year's budget with clear allocations for development projects across departments and wards. However, we are already in the second quarter, yet procurement activities have not commenced and there is no visible progress on the ground. This delay raises concern over the absorption of development funds and the timely delivery of essential services to the people of Taita Taveta County.
- **Mr. Speaker, Sir,** it is in this regard that I request the Chairperson Budget, Finance and Appropriations Committee to provide a Statement on the following matters within fourteen (14) days:
 - 1. The status of procurement processes for all approved development projects for FY 2025/2026, indicating progress across departments;
 - 2. The funds released and utilized to date, including absorption rates per department;
 - 3. The challenges causing delays in procurement and implementation;
 - 4. The measures being taken by the Executive to fast-track the implementation of projects; and
 - 5. The timelines for completion of projects to ensure full utilization of development funds within the financial year.
